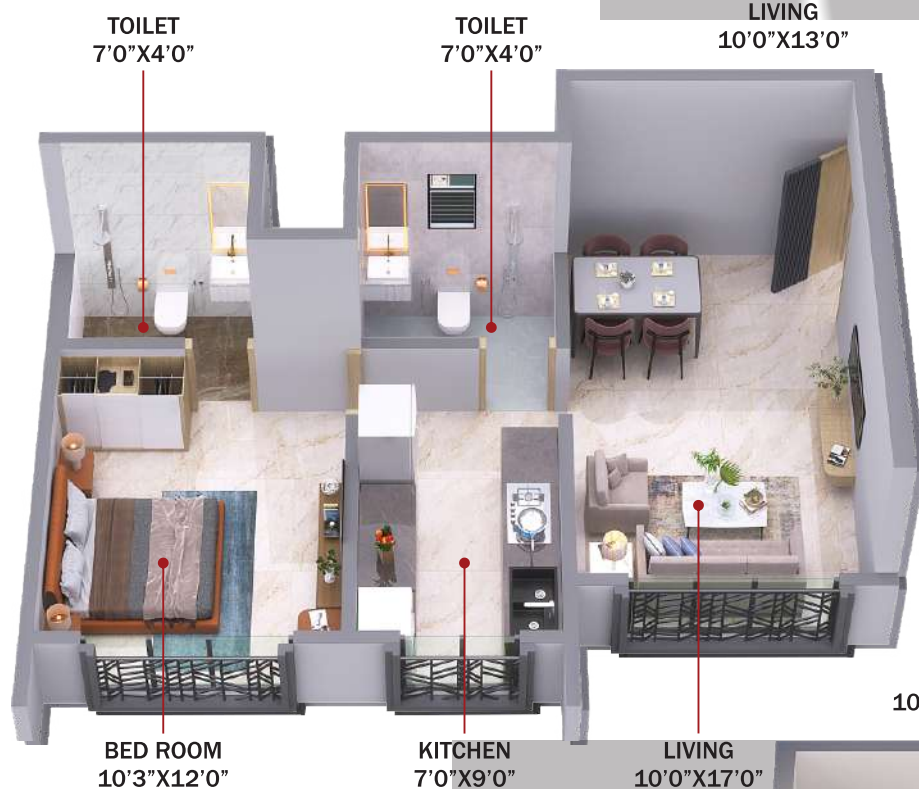
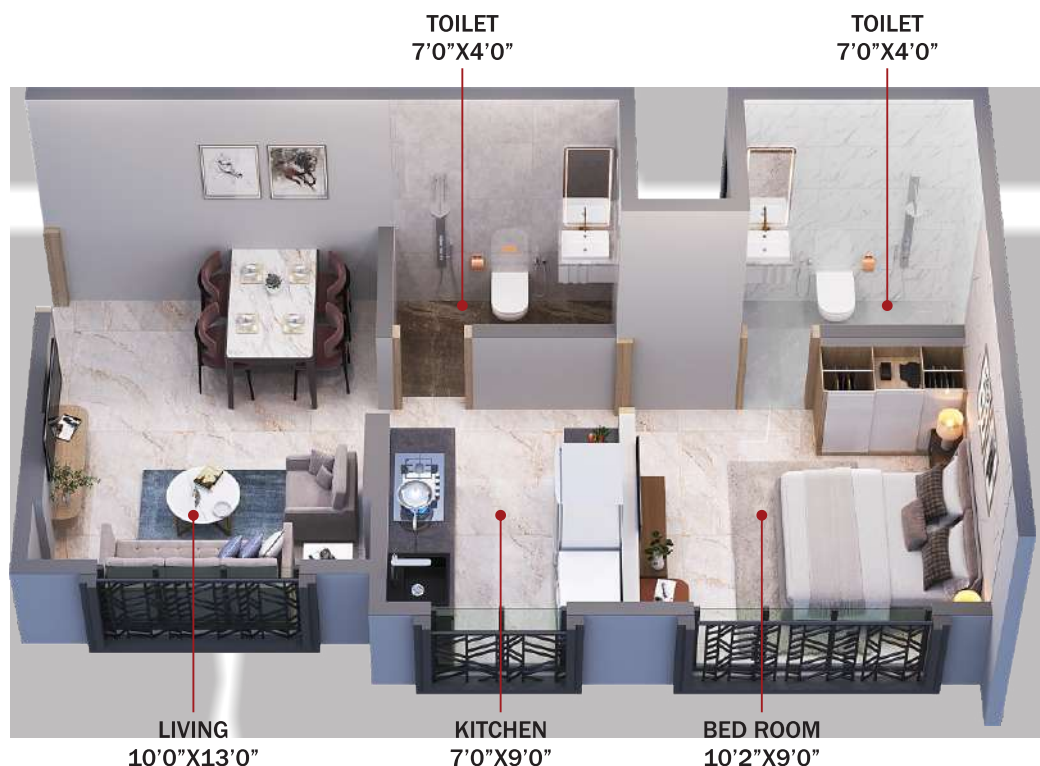
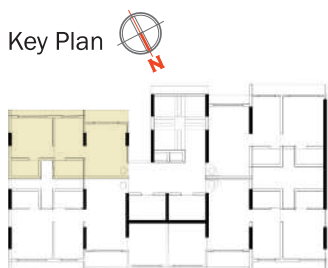


10TH, 12TH & 14TH FLOOR PLAN

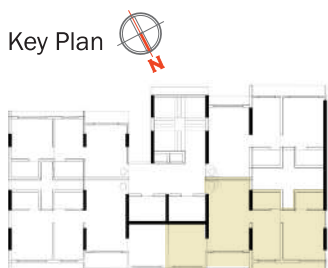
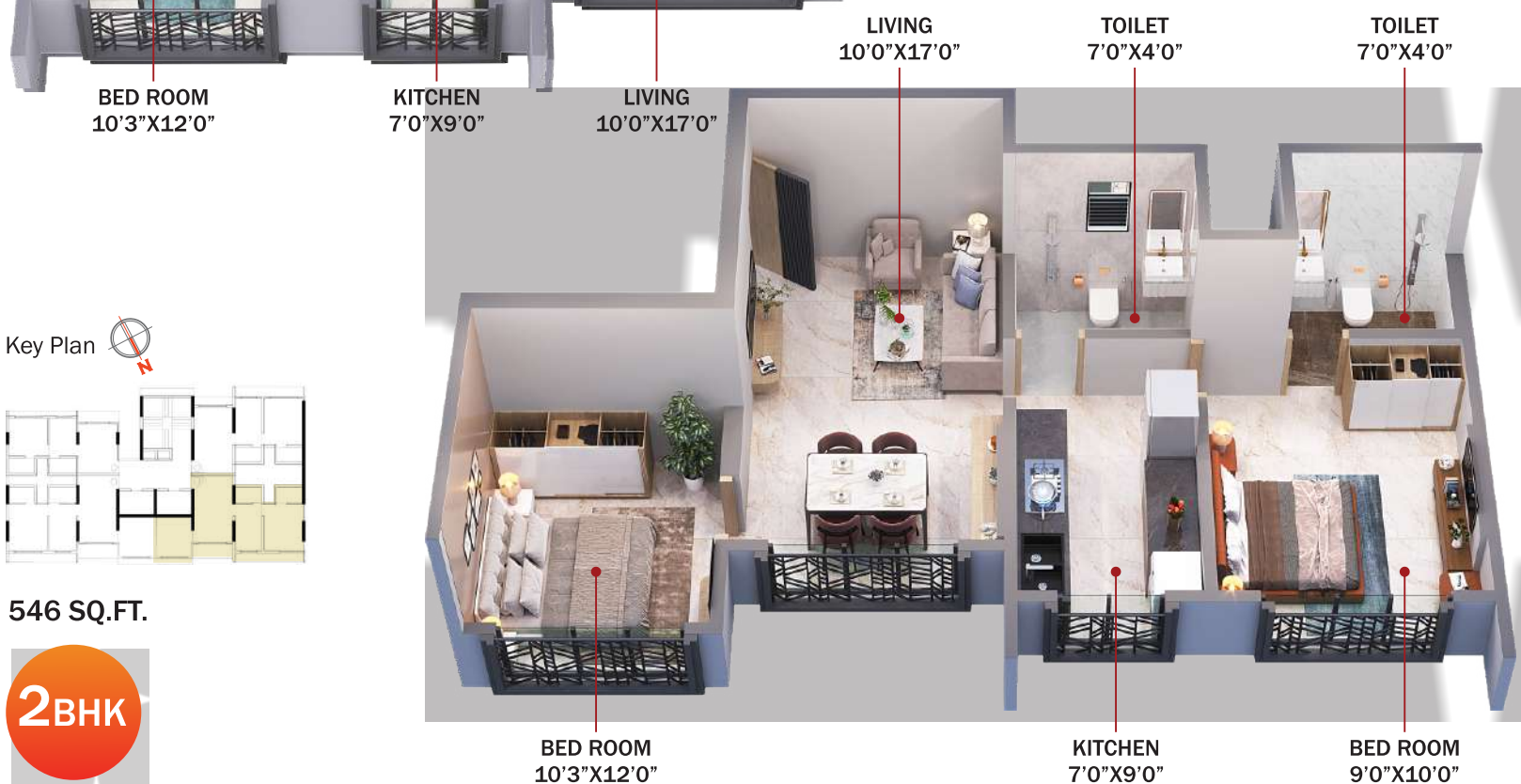
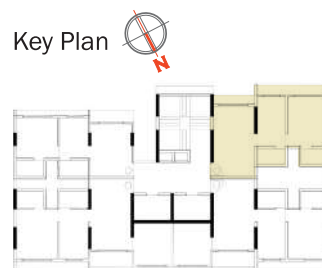
